

# AIA Engineering - Micro turnaround

Aditya Birla Sun Life AMC Ltd.



#### **Company Background**

- AIA Engineering is a niche player in the value-added, impact abrasion, and corrosion resistant high chrome metallurgy segment with current capacity of 200,000 Mtpa
- It manufacturers products like grinding media, liners, diaphragms, and vertical mill parts (collectively referred to as mill internals) in high chrome metallurgy

Catalyst Playing out	<ul> <li>Entry into high potential gold and copper ore markets (addressable market ~1.2mn Mtpa), which account for ~40% plus of the overall market bodes well from a medium-term perspective, as they have been traditionally stronger in metals like iron ore.</li> </ul>
Investment Rationale	<ul> <li>90-95% of the mining demand is currently being serviced by conventional and forged mill internals. With the industry moving from cost of parts to total cost of ownership, there is a huge opportunity for AIA to convert users to high chrome mill internals.</li> <li>Despite the overall challenging environment, AIAE is continuing with its capex plans to fuel long-term</li> <li>Volumes are expected to pick up as demand normalizes</li> <li>Positive long-term outlook on AIAE due to low penetration (10-12%) of high chrome grinding media in the ~3 mn MT mining segment(especially gold and copper verticals).</li> </ul>

# Bharti Airtel - Macro Turnaround

Aditya Birla Sun Life AMC Ltd.



#### **Business: Communication**

- Bharti Airtel is a leading global telecommunications company with operations in 17 countries across Asia and Africa. The company ranks among the top three mobile service providers globally in terms of subscribers at 490+ mn.
- Airtel ranks among the top three mobile operators globally covering over two billion people. It is the second largest mobile operator in Africa. They are constantly transforming adjacencies including Payments Bank, AdTech, data centres, cloud communications, and digital marketplace into impactful businesses

Catalyst Playing out	<ul> <li>Bharti Airtel is well positioned to benefit from the improving sector dynamics led by improvement in ARPUs. Improving data usage, lower selling &amp; distribution expenses, growth in home broadband &amp; positive outcome of AGR issues bode well for the telecom sector.</li> </ul>
Investment Rationale	<ul> <li>In contrast to fears, the company has witnessed only limited churn post RJio's recent Jio fiber launch (35-40% of recent plan renewals were annual). The recently launched 'Xstream' website and app (rebranded version of Airtel Thanks) offer wide content, which should further increase FTTH subscriber stickiness.</li> <li>ARPU accretion from broadband subscribers (2x ARPU v/s voice only subs) is likely to contribute to growth. We expect consolidated EBITDA CAGR of around 25% over FY20-24 due to the above-mentioned reasons.</li> <li>The steady EBITDA performance, deleveraging and the improving Free cash flow position have helped protected the stock even in the weak market. With the AGR verdict behind, the profitability of the sector is expected to improve due to the impending price hikes.</li> </ul>

# **Trent Limited - Mid to large cap potential**

#### **Business: Retail**

- Trent is one of the leading players in the Indian retail industry with a series of established brands in various retail segments
- Trent operates in multiple retail formats in both the value and lifestyle segments such as Westside (lifestyle), Zara (lifestyle), Star Bazaar (Hypermarket) and Landmark (books and music).

Catalyst	<ul> <li>One of the few retailers to get the business model right, having 95% private label, and 53% gross margins along with consistent</li></ul>
Playing out	SSG (average of 9% over FY13-17), resulting in industry leading margins and RoCE of (9.7%/15%)
Investment Rationale	<ul> <li>Trent was among the earliest entrants in the organised retail sector in India and has focused on developing a robust business model in each of the retail formats pursued. Trent is pre-dominantly present in high growth / profitable women wear portfolio (~60 efficiently managing supply-chain / inventories which itself creates a strong entry barriers for peers.</li> <li>Zara, where Trent has a 50% stake (in the JV with Inditex), is a jewel in the company's crown.</li> </ul>


